IN CONSIDERATION FOR participation in this event, _____, I, the undersigned parent/legal guardian, hereby agree as follows:

- I understand that the Discovery Boat Program is a Glen Lake Association sponsored event in which participants learn about the Glen Lake/Crystal River Watershed.
- By signing this Permission Form and Liability Waiver, I acknowledge that I have voluntarily chosen to participate in in this event, and (if applicable) that I have voluntarily allowed my child to participate in this event.
- I forever release, waive, and discharge the Glen Lake Association and each of its respective members, agents, employees, officers, board members, independent contractors, volunteers, and all other persons or entities acting under their direction and control (collectively referred to as “the Released Parties”) from, and agree not to pursue a claim or sue the Released Parties or any of them individually for, any liability, claim, or expense resulting from injury, illness, damage, death or loss in any way associated with myself and if applicable, my child’s participation in this Discovery Boat Event or the use of any equipment or facilities related to this Event.
- I further agree to defend and indemnify the Released Parties (to pay or reimburse the Released Parties for money they are required to pay, including attorney’s fees and costs) with respect to any and all claims brought by or on behalf of me, my child, a family member, personal representative, estate, a co-participant, or any other person for any claims related to my child’s participation in this event or my child’s use of equipment or facilities, including claims that staff, or volunteers were negligent. This indemnity includes payment for attorney’s fees and costs incurred by the Released Parties in defending a claim or suit if the claim or suit is withdrawn or where a court determines that the Released Parties are not liable for the injury or loss.
- I further understand that the Glen Lake Association may not carry any insurance relative to this event or for participant injuries. I understand that, as the parent/legal guardian of the event participant, I am responsible for all emergency or medical fees and/or costs incurred as a result of emergency circumstances.
